

Arrangements concerning registration of full-time students of English-language studies for the summer semester 24L in the academic year 2023/2024

Registration will be conducted according to the following schedule:

1. The initial registration decisions will be announced on **12 February 2024 (Monday)** in the USOS-web portal on individual student accounts (status of passing or failing a summer semester of studies and registration for the next semester or no registration).
2. The submission of students' explanations of achievements obtained in semester 2023Z will take place on **13 February 2024 (Tuesday) from 10:00 am.**
- **For students of semesters 1-6 of B.Sc. programme who expect unfavorable registration decisions, it is necessary to submit an application containing the student's explanations in the USOS-web portal by 12 February 2024, (Monday) by 6:00 p.m. *.)**

Decisions will be provided to students e-mails who submitted explanations in the portal USOS-web in response to the application, in the form of the Vice-Dean's decision, in addition, in selected cases interviews will be held with the students using the MS Teams application according to the following schedule (the interview will be initiated by the Vice-Dean):

Semesters 1 – 6 of B.Sc. English-language programme –from 15:00 to 16:00 hrs.

- **For students of semesters: 7 - 8 and 8 + 1 of B.Sc. programme, as well as For students of M.Sc. programme of English-language studies,** explanations should be sent to the appropriate Deputy Director for Academic Affairs of the Institute to which the student is assigned to, **by 13 February 2024 (Tuesday), by 10:00 a.m.**

Decisions will be sent to the e-mail addresses of students submitting explanations, moreover, in selected cases, interviews with students will be conducted using the MS Teams application at the initiative of the appropriate Director.

4. Submitting **written appeals** by students against registration decisions, to the Dean, prof. Michał Malinowski, will be held **until 14 February 2024 (Wednesday), by 6:00 p.m.**

Appeals to the Dean should be submitted to the USOS-web portal along with explanations*)

5. Decisions of the Dean will be provided **to students submitting appeals in the USOS-web portal**, and in selected cases **from 10:00 a.m.** interviews will be conducted with students using MS Teams application. The interview will be initiated by the Dean.
